Mangala Rural Municipality, Office Of the Rural Municipal Executive has allocated funds towards the Cost of Construction of Poka- Satbise- Jyamire-Toridanda- Khasrupani-3 no ward office to 4 no Ward office road. And intends to apply part of the funds to cover eligible payments under the Contract for MRM/NCB/WORKS/2/2078/079. Bidding is open to all eligible as per Section V of bidding document..
2. Mangala Rural Municipality invites electronic bids from eligible bidders for the construction of Poka- Satbise- Jyamire-Toridanda- Khasrupani-3 no ward office to 4 no Ward office road under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 35.6 million
- Minimum Work experience of similar size and nature: 22.3 million

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

7. electronic bids must be submitted to the office Mangala Rural Municipality, Babiyachaur, Myagdi through PPMO's e-GP system www.bolpatra.gov.np/egp on 12Hrs on 2078/06/01 . Bids received after this deadline will be rejected.
8. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hrs on 2078/06/01 at the office of Mangala Rural Municipality, Babiyachaur, Myagdi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs.6,95,000, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Other Thing not included in Bidding documents will be as per PPA,2063 and PPR,2064.
