The Government of Nepal [GoN] has allocated funds or received a loan/credit/grant from Mangala Rural Municipality towards the cost of Construction Of Poka- Satbise - jyamire - Toridanda -Khasrupani-3 no ward office to 4 No. Ward office Road and intends to apply part of the funds to cover eligible payments under the Contract **for 06/MRM/2076/077**. Bidding is open to all eligible as per Section V of bidding document.
2. Mangala Rural Municipality invites electronic bids from eligible bidders for the construction of **Back cutting, excavation for masonry structure, side drain, and masonry structure** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **34 Million**
 - Minimum Work experience of similar size and nature: 5 years
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidder must submit their bid electronically by downloading the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (Rs 5000) of bidding document in specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Pre-bid meeting shall be held at Mangala Rural Municipality at **2076/10/20 at 11 am**.
7. Electronic bids must be submitted to the office Mangala Rural Municipality, Babiyachaur, Myagdi through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 pm** on **2076/10/29** Bids received after this deadline will be rejected.
8. The bidswill be opened in the presence of Bidders' representatives who choose to attend at **13:00** at the office of Babiyachaur, Myagdi. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **(2.5% of estimated amount) ie. Nrs 665000**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
